# ORDINANCE NO. 17-62-14-2

## AN ORDINANCE ESTABLISHING PARKING RESTRICTIONS

WHEREAS, it is necessary for the general health, welfare, and safety of the public and the residents of the Town of Borden that parking be regulated within the Town;

WHEREAS, vehicles can obstruct the free passage of motorists on residential streets and create hazardous conditions especially during night-time hours;

WHEREAS, vehicles can obstruct the free passage of emergency, waste disposal, and snow removal vehicles on residential streets; and

WHEREAS, it is the desire of the Town Council of the Town of Borden to establish parking regulations and a schedule of fines for violations of those regulations.

### NOW, THEREFORE, BE IT ORDAINED:

### ARTICLE 1: DEFINITIONS

For the purposes of this ordinance, the term "vehicle" means every device, in, upon, or by which any person or property is or may be transported or drawn or moved upon a street, highway, waterway, or airway and shall include any automobile, bus, truck, motorcycle, moped, motor home, boat, aircraft, recreational vehicle, trailer, fifth-wheel trailer, camper, or camper shell.

# ARTICLE 2: PARKING PROHIBITED OR LIMITED IN DESIGNATED PLACES

(A) Posted Signs. No person shall stop, park, or leave standing a vehicle at any time upon any street, alley, municipal parking facility, or highway in any area where appropriate signs or markings have been placed indicating that parking is prohibited or that the area is a no-parking zone, nor in any area where signs have

been placed indicating that parking is limited to a specified length of time for a period longer than specified upon such signs, nor in any area where signs have been placed indicating that parking is prohibited during certain hours of the day or days or portions of days of the week, during hours or portions of days during the times when parking is prohibited as directed on such signs.

- (B) Overnight parking. It shall be unlawful for the owner, operator, or driver of a vehicle to park such vehicle or to permit it to be parked or to stand upon the following streets in the Town of Borden between the hours of 10:00 p.m. and 7:00 a.m.
  - (1) Borden Ridge Drive
  - (2) Brewer Drive
  - (3) Stark Drive
  - (4) Vine Court

### **ARTICLE 3: PENALTIES**

The fine for violating any provision in this ordinance shall be one hundred dollars (\$100.00) per violation. Fines paid pursuant to this ordinance shall be paid at the Ordinance Violations Bureau and are hereby incorporated into the fine schedule of Ordinance No. 17-01-10.

### ARTICLE 4. MISCELLANEOUS PROVISIONS.

- (A) All ordinances or part of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency. Provided, however, that such repeal shall be only to the extent of such inconsistency, and in all other respects the ordinance or parts of ordinance are hereby ratified, re-established, and confirmed.
- (B) If any part of this ordinance is held to be invalid, such part will be deemed severable and its invalidity will have no effect upon the remaining provisions of this ordinance.

### ARTICLE 5. EFFECTIVE DATE.

The ordinance shall be in full force and effect from and after its passage and due publication.
