### **ROLL CALL:**

### **SEWER DEPARTMENT:**

Pierce from JTL gave the Sewer Update regarding the StarValley Sewer project.

- Discussion of Change Orders for StarValley Sewer Project
  - Change Order 1 for Project # 22126-1– PAF encountered an unmarked 4" Force Main Line. Cost for fixing - \$9,032.90. Break was fixed by Lossom.
    - Rudy made the motion to approve Change order #1 in the amount of \$9032.90, LeAnn to second, no opposed, motion carried.
  - Change Order 2 for Project #22126-1 is to extend the contract to move up the hill holding back \$71,000 for INDOT. Change order is in the amount of \$244,634.00.
    - Rudy made the motion to approve Change order #2 in the amount of \$244,634.00, LeAnn to second, no opposed, motion carried.
- JTL Contract
  - Discussion of Amended contract for JTL as outlined in Amendment No 1. Will extend the additional administration and inspection services for the additional scope of work which would be approximately 1,600 linear feet of sewer. Cost for expanded services is \$82,750.
    - Rudy made the motion to approve Amendment No 1 for extended services by JTL in the amount of \$82,750.00, LeAnn to second, no opposed, motion carried.
