Police Department Update (Chief Jones)

- One reserve officer to join in January (pre-basic required).

- Equipment is in good shape.
- Received two used tasers from the Sheriff's Department.
- Applied to the Lions Club for \$2,000 towards vests and portable breathalyzers.
- Applied to the Wood Carr Foundation for an additional \$2,000.
- Received a federal COPS grant for a new police officer starting in January.

Town Business (Brennan)

- Wood Township interlocal agreement to be delivered. The resolution was signed and delivered.
- Trick or treating is October 31st, 6-8 PM.
 - Subdivision will be blocked off.
 - Asking if the county will assist.
- Christmas party: Wednesday, December 10th at 7 PM.

- Capital Group Simple IRA: The Town would be able to offer the 401K benefit after 1 year of
 employment instead of 2 years. Matt asked if we had an employee handbook. Brenna
 shared that we don't have one; we have just completed one for the police department, but
 she was developing a handbook with the town's policies and procedures and would include
 that information.

The council discussed why there was such a big difference, but it is due to that Temple was awarded the bid for the parking lot at the Town Hall, and they will have their equipment in town. The scope is the same.

- COP Grant: Waiting for directions on how to proceed, once the government opens back up.
- Park erosion money: Quote from Billy Kirchgessner for \$7,800, plus additional costs for blocks and riprap. To be addressed with the park board and the Friends board.
